BACKGROUND INFORMATION

This process pertains to an application for site plan approval pursuant to Section 41 of the *Planning Act*. Prior to the Municipality processing the application, it is required that a copy of the attached application form be completed including five (5) copies of the site plan submission package detailing the requirements of Section 15 of this application and the processing fee of \$1350 (or \$700 for an amendment to an existing agreement). Please also note that the Municipality requires an electronic submission of all drawings that form part of the application.

Please note:

- The application must be completed in metric units.
- The site plan must be prepared by a qualified professional such as a civil engineer, architect, planner, landscape architect or land surveyor.
- The site plan shall have regard for the Municipality's Urban Design Guidelines and Site Plan Manual.
- The receipt of inaccurate information may cause delays in the processing of this application.
- Additional information, studies and/or reports may be required by the Municipality prior to approval being granted. The Municipality reserves the right to determine what information is necessary in order to properly process an application.
- Any external consultants' costs that the municipality may incur as a result of the review of this application will be the responsibility of the applicant as noted on page 3 of this application.

APPLICATION PROCESS

Step 1	Consult with Planning Staff: Applicants are encouraged to meet with Staff prior to submitting an application.
Step 2	Application submission: Complete the attached application form and include the required site plan drawings and processing fee.
Step 3	Complete application accepted: The file is opened and timelines for processing are established.
Step 4	Application Circulation: The application is circulated to agencies and municipal departments for review and comment.

Step 5	Evaluation: Staff undertakes an evaluation of the application using the relevant planning policy documents and the Comprehensive Zoning By-law. A site plan agreement is also prepared which stipulates the terms of the development of the subject land. The applicant is advised of any recommended changes. If the applicant disagrees with any of staff's recommendations, the proposal is forwarded to the Municipal Council for consideration.
Step 6	Consideration before Municipal Council: Upon the completion of satisfactory site plan drawings and associated site plan agreement, the implementing by-law is forwarded to Municipal Council for consideration of approval.
Step 7	Agreement Registration: Once you have signed the site plan agreement, your solicitor is required to register the agreement against the title of the subject land.
Step 8	Building Permit: Upon receipt of written confirmation of the registration of the agreement, the Municipality's Chief Building Official will be in a position to issue a building permit to commence the proposal, pending the approval of building plans and the payment of various fees; including but not limited to site plan security, development charges and building permit fees.

APPEAL TO THE LOCAL PLANNING APPEAL TRIBUNAL

The applicant has the right to appeal Municipal Council's decision to the Local Planning Appeal Tribunal (LPAT) if the Municipality fails to approve the Site Plan within 30 days after being submitted or if the Municipality has imposed a Site Plan requirement that the applicant finds unreasonable. The appeal must be filed with the secretary of the LPAT and the Clerk of the Municipality. An appeal to the LPAT must be accompanied by the required forms, downloadable from the LPAT website (<http://www.olt.gov.on.ca>), including the fee. If an appeal is received, the LPAT will arrange for a hearing, which currently may take up to six months to schedule. The decision of the LPAT is considered final.

There are no third-party appeal rights in respect of site plan approval.
