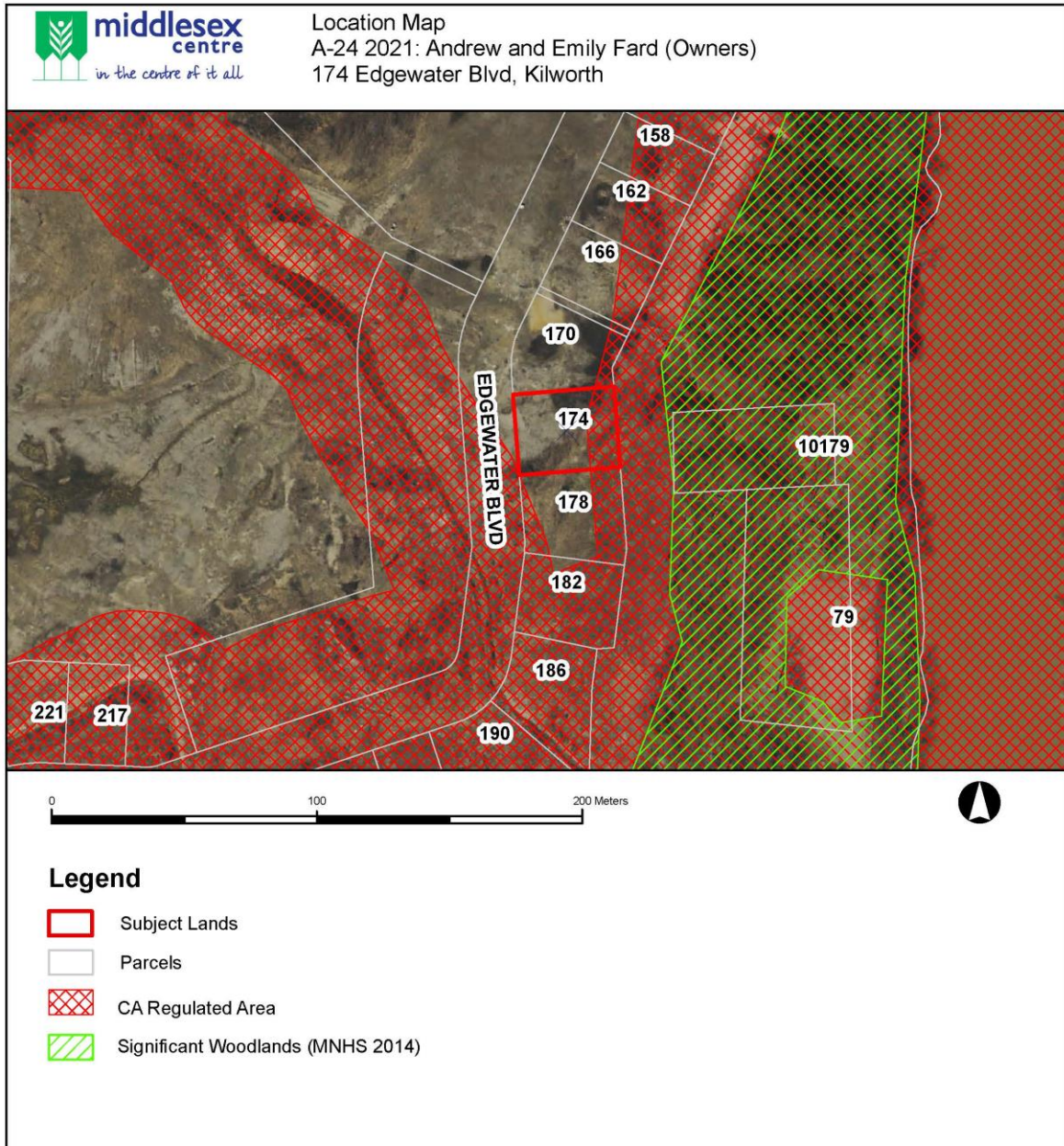
Purpose and Effect of the Application:

The Municipality is seeking input on a development application within 60 metres of your property. The purpose and effect of the Application for Minor Variance is to seek relief from the Middlesex Centre Comprehensive Zoning By-law 2005-005 as it relates to the maximum lot coverage permitted in the Urban Residential First Density (UR1) Zone. The applicant is requesting a maximum permitted lot coverage of 40.12 percent for the house and accessory buildings, whereas the Middlesex Centre Comprehensive Zoning By-law permits a maximum lot coverage of 35 percent for the main use, with an additional 3 percent is afforded for accessory buildings. The effect of the proposal is to facilitate the construction of a two storey home with a covered porch at the front of the property and covered deck at the rear of the property. The request is summarized below:

Requirements	Relief Requested
As per section 8.1.7, the maximum lot coverage for the main building on a lot is 35% for the main building, and 38% for all buildings inclusive of accessory buildings, subject to Section 4.1 a).	Additional 2.12% lot coverage for all structures on the lands (24.6 square metres)

Description and Location of the Subject Lands:

The subject property is located on the east side of Edgewater Boulevard, in the South Winds subdivision in Kilworth. The land is legally described as Lot 67, Plan 33M746 in the Municipality of Middlesex Centre, County of Middlesex.

What can I expect at the Public Meeting?

The public meeting is an opportunity for members of the public to learn more about the proposed development. You will have the opportunity to hear a brief presentation about the development, ask questions, and/or make statements either in favour of, or in opposition to the development.

The public meeting will take place during a Council meeting and the mayor will keep the meeting in order and allow the applicant (or their development team), the registered public participants, and Council to speak and ask questions.

You are invited to participate in the public meeting by submitting comments and/or concerns via email to planning@middlesexcentre.on.ca in advance of the meeting or by registering to participate in the public meeting by calling in and joining the meeting online via Zoom. If you have questions about the application we encourage you to contact the Planner directly in advance of the meeting and they may be able to answer your questions.

To register to participate in the public meeting by phone please send your request to participate no later than the Monday prior to the meeting via email to planning@middlesexcentre.on.ca and provide the following information: Your First and Last Name, the phone number that you will be calling in on, your home address with postal code, and prepared speaking notes. Speaking notes will be forwarded to Council in advance of the meeting for their information and consideration. If for any reason you cannot connect or you lose your connection the meeting will continue to proceed in our absence, however council will have your comments concerns in advance to take into consideration. Only those that register to participate will be permitted to call in.

What if I can't participate in a Public Meeting?

You may choose to submit comments via letter or email, however at this time an email is encouraged. Why is this Public Meeting being held and what are your rights?

Within Ontario, the planning and development process is open and transparent, where opinions from all individuals and groups are welcomed. By law municipalities must hold a public meeting. This meeting is one of your chances to learn about the development proposal and offer your opinions.

Under the legislation governing this development process, which is Section 45 of the *Planning Act*, you have the following rights:

1. If you do not attend or are not represented at the Hearing, the Committee may proceed in your absence and you will not be entitled to any further notice of the proceedings. Written comments may be submitted to the Secretary-Treasurer prior to the Hearing. Please note that all written material submitted and verbal comments presented will form part of the public record and will be available for full disclosure.
2. Any persons may attend the public meeting and/or make written or verbal representation either in support of or in opposition to the proposed Minor Variance Application.
3. If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality before the Minor Variance Application is approved or refused;
 - a. the person or public body is not entitled to appeal the decision of the Municipality of Middlesex Centre to the Local Planning Appeal Tribunal,
 - b. the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.
4. If you wish to be notified of the decision of Council of the Municipality of Middlesex Centre in regards to the proposed Minor Variance Application, you must make a written request to the Planning Division of the Municipality of Middlesex Centre at 10227 Ilderton Road, RR #2, Ilderton, ON N0M 2A0.

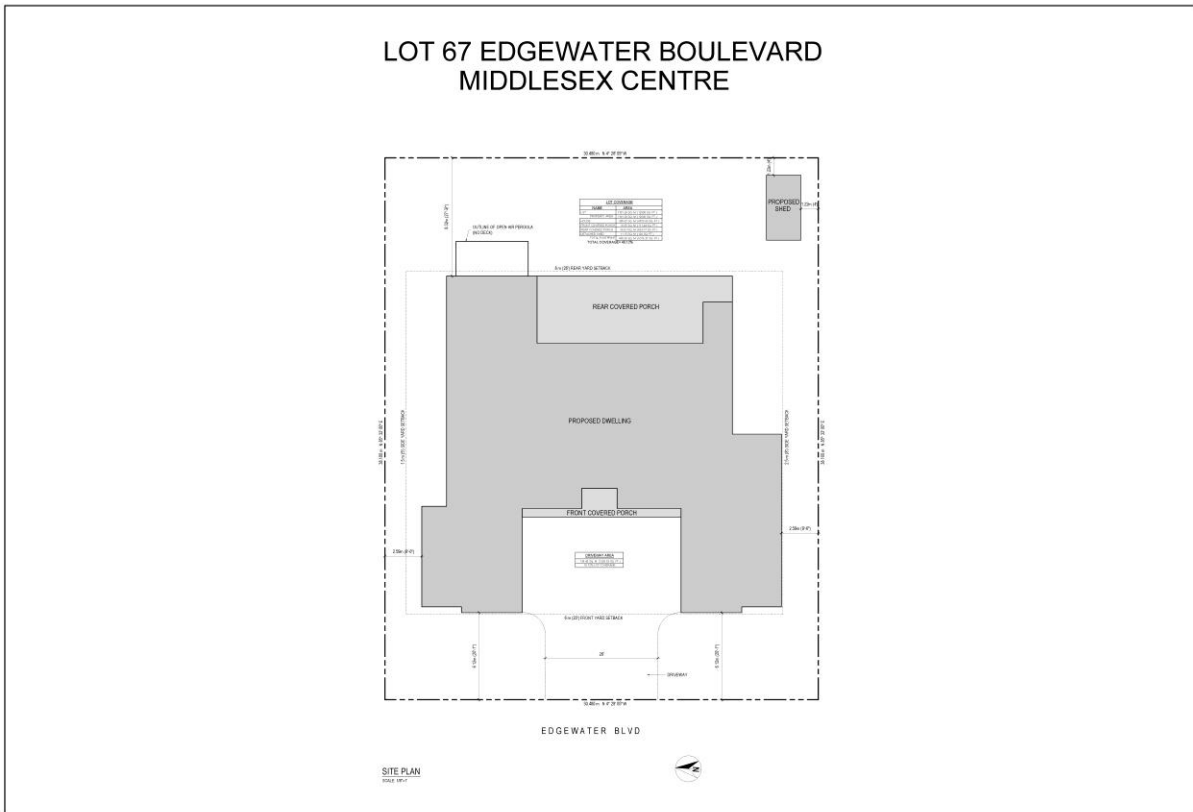
