#### Purpose and Effect of the Application


The Municipality is seeking input on a development application within 60 metres of your property. The purpose and effect of the Application for Minor Variance is to seek relief from the Middlesex Centre Comprehensive Zoning By-law 2005-005 as it relates to the minimum rear yard setback requirement for a deck in the Urban Residential First Density – exception (UR1-41) Zone. The applicant is proposing to construct a deck in the rear yard with a minimum setback of 4.8 metres, whereas the Zoning By-law requires a minimum setback of 6.5 metres. The effect of the variance is to construct an uncovered outdoor deck.

#### **Proposal Summary**

As per section 4.30, the maximum rear yard encroachment is 1.5 metres, and as per section 8.1.6, the minimum rear yard setback is 8 metres	minimum rear yard setback of 4.8 metres

#### **Description and Location of the Subject Lands**

The subject property is located on the south side of Oxbow Drive, north of the intersection at Queen Street and Oxbow Drive. The land is legally described as Part of lot 6, Concession 2 Lobo, Part 2 on Reference Plan 33R20376, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 10083 Oxbow Drive.

#### **Other Information**

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 45(12) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
