The Committee of Adjustment will hold a public meeting to gather feedback regarding the Minor Variance application to consider the proposal. The details are as follows:



## Purpose and Effect of the Application

The Municipality is seeking input on a development application within 60 metres of your property. The purpose and effect of the Application for Minor Variance is to seek relief from the Middlesex Centre Comprehensive Zoning By-law 2005-005 as it relates to a defined use in the Farm Industrial – Exception (M3-2) Zone. The current zone limits uses on-site to those that specifically service agricultural equipment. The applicant is requesting permission to establish a Krown Rust protection business which would service both agricultural and non agricultural vehicles as an automotive service establishment.

#### **Description and Location of the Subject Lands**

The subject property is located on the south side of Gainsborough Road, east of the intersection at Vanneck Road and Gainsborough Road. The land is legally described as Part of Lot 31, Concession 3, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 1830 Gainsborough Road.

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. - 3) **SPEAK TO COUNCIL** remotely by pre-registering with the Planning Department by emailing <u>planning@middlesexcentre.ca</u>. Upon receipt of your email, you will receive a reply with instructions for obtaining your unique Zoom link in order to participate in the Public Meeting.
- ATTEND THE MEETING IN PERSON at the Ilderton Community Centre (13168 Ilderton Rd). Any members of the public who wish to speak to an application will be given the opportunity to do so.

## **Other Information**

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 45(12) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
