#### **Purpose and Effect of the Application**


The Municipality is seeking input on a development application within 60 metres of your property. The purpose and effect of the Application for Minor Variance is to seek relief from the Middlesex Centre Comprehensive Zoning By-law 2005-005 as it relates to the minimum permitted interior side yard setback required for the site-specific Highway Commercial – exception (C2-9) Zone. The applicant is proposing an interior side yard setback of 3.5 metres (11.4 feet), whereas the zone requires a minimum interior side yard setback of 6.0 metres. The effect of the variance is to permit a future severance of the lands for a proposed multi-family residential block with a reduced interior side yard setback of the commercial building.

# **Description and Location of the Subject Lands**

The subject property is located on the southeast side of Glendon Drive, southeast of the intersection of Glendon Drive and Jeffries Road, and is municipally addressed 22428 Jeffries Road. The land is legally described as Part of Block 60, Plan 33M656, in the Municipality of Middlesex Centre, County of Middlesex.

#### Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 45(12) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
